Right of Entry

It is almost impossible for a surveyor to properly perform boundary retracement surveying services without entering on the neighbor's property. In some cases, the entry upon the neighbor's property may be unintentional due

to the initial uncertainty in regard to the location of the common boundary. In most cases, entry on the neighbor's property is essential in order for the surveyor to gather all the evidence necessary to arrive at an unbiased and fully supported opinion on the location of the common boundary. This presentation will discuss the common law liability exposure for the surveyor when entering on the neighbor's property. The presentation will explain how the right of entry statute protects the surveyor and how the surveyor should utilize the right of entry statute.
